Single-Feeding, Extruded Bait

CONTRAC All-Weather Cake is a single-feeding bait available in a weather-proof form. Its active ingredient, Bromadiolone, produces mortality in a single feeding, even in anticoagulant-resistant rodents.

CONTRAC All-Weather Cake is designed for high moisture conditions and retards the chance of mold or rancidity occurring. To assure acceptability by rats and mice, only human food-grade inert materials and enhancers are used.

Labelled for the control of Norway rats, roof rats, and house mice, CONTRAC All-Weather Cake can be used indoors and outside in bait stations, around structures, in burrows, or along rodent runways. It is colored blue for easy recognition as a non-food item and is authorized by USDA for use in federally inspected meat and poultry plants.

CONTRAC All-Weather Cake is manufactured in multi-edged, scored cakes that can be broken into 4-oz., 2-oz., or 1-oz. blocks for rat or mouse placements.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

READ THIS LABEL: Read this entire label and follow all use directions and use precautions.

IMPORTANT: Do not expose children, pets, or other nontarget animals to rodenticides. To help to prevent accidents:

1. Store product not in use in a location out of reach of children and pets.
2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.
3. Dispose of product container and unused, spoiled, and unconsumed bait as specified on this label.

USE RESTRICTIONS:

For control of Norway rats, roof rats and house mice.

URBAN AREAS:

This product may be used in and around the periphery of homes, industrial, commercial, and public buildings. This product may also be used in transport vehicles (ships, trains, aircraft) and in and around related port or terminal buildings. This product may also be used in alleys. Do not use in sewers.

NON-URBAN AREAS:

This product may be used inside of homes and agricultural buildings.

Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food. Do not broadcast bait.

SELECTION OF TREATMENT AREAS: Determine areas where rats or mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect from rain or snow. Remove as much alternative food as possible.

Norway rats and house mice may consume a lethal dose in one feeding with first dead rodents appearing four or five days after treatment begins.

DIRECTIONS FOR USE (Continued from other panel)

APPLICATION DIRECTIONS:

Each CONTRAC CAKE consists of a one-pound slab scored to be broken into four 4-oz. pieces.

RATS: Break and apply 1 to 4 pieces of CONTRAC CAKE (usually at intervals of 15 to 30 feet) per placement. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

MICE: Obtain 1-oz. bait pieces by breaking 4-oz. pieces of CONTRAC CAKE in half and breaking each half in half. Use one 1-oz. piece of CONTRAC CAKE per bait placement. Space placements at 8- to 12-foot intervals. Two 1-oz. pieces may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days or until signs of mouse activity cease.

RATS AND MICE: Replace contaminated or spoiled bait immediately. Collect and dispose of all dead exposed animals and leftover bait properly. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store only in original container in a dry area inaccessible to children and pets.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Dispose of empty carton in a sanitary landfill or by incineration. If burned, stay out of smoke.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS CAUTION

Keep away from humans, domestic animals and pets. If swallowed, this material may reduce the clotting ability of the blood and cause bleeding. Avoid contact with eyes or clothing.
